CONFESSION – Once a confessional statement is admitted in evidence, it becomes part of the case for the prosecution which the judge is bound to consider for its probative value – EGBOGHONOME V STATE 1993 13 LRCN Pt. CONFESSIONAL STATEMENT – CONFIRMATION BEFORE SUPERIOR POLICE OFFICER – Is a desirable practice but not a requirement of law – RV SAPELE 1957 2 FSC 24;

CONFESSIONAL STATEMENT – INCREIMINATION CO-ACCUSED – Confession is only against the maker. It is not admissible against other accused unless corroborated by other evidence – EMEKA V STATE supra.

CONFESSION – NEED FOR TRIAL WITHIN TRIAL – When the voluntariness of a confession is raised the court must conduct a trail within trial – EMEKA V STATE supra.

CONFESSION – TRAIL WITHIN TRIAL – IRREGULARITY – Where the trial court wrongly calls upon the Accused to start in a trial within trial, it amounts to an irregularity. If it does not cause a miscarriage of justice the conviction will not be set aside – EMEKA V STATE supra.
